Description 1: Ethics for Gambling Disorder

This training discusses various ethical considerations as they pertain to individuals with a gambling disorder. We will review the IGCCB Code of Ethics and discuss the importance of each principle. Clinicians will review cases and apply the ethical decision-making model.

Description 2: The Legal System related to Gambling Disorder

The second part of this training explores the various ways in which clinicians may be involved in the legal system related to gambling disorders. For many, it's not "if" but "when" they will interact with attorneys, probation/parole, and court-ordered treatment requests. Clinicians will learn more about "Gambling-motivated-crime" as a concept unique to gambling disorders.

Description 3: Responsible Gambling

The third section of this training introduces clinical approaches to harm reduction across the continuum, from responsible gambling to self-exclusion programs. Clinicians will learn how to apply the 10 Rules of Responsible Gambling to create harm reduction plans for their clients.

- 6. Define what is Harm Reduction on a continuum.
- 7. Describe how to apply harm reduction with problem and disordered gambling.
- 8. Discuss how to use the 10 Rules of Responsible Gambling for harm reduction plans
