Message From Our Executive Director

Dear Friends and Supporters,

In 2024, Connecticut's legal gambling boom delivered eye-opening numbers—and a powerful call to action. Since online casino gaming and sports wagering debuted in October 2021, our communities have wagered nearly \$45 billion, incurring \$1.8 billion in losses. State revenues surged from \$56 million in 2022 to over \$98 million in 2024—but strikingly, half of that sports-betting income came from just 2% of bettors. These figures make one thing clear: high-risk play is concentrated, and targeted prevention is more urgent than ever.

We answered that call by transforming our helpline and outreach. In 2024 alone, contacts to our 24/7 support line jumped 132%. Working hand-in-hand with community partners, we launched a statewide public-awareness campaign—across digital platforms, community events, and broadcast spots—to expose illegal machines, highlight self-exclusion tools, and remind every Connecticut resident that help is just a call or chat away. We also empowered the next generation through our College Campus Gambling Prevention Initiative, funding ten campuses to lead student campaigns, developing policies, delivering peer trainings, and hosting interactive webinars. Recognizing that gambling harm affects all corners of our state, we rolled out our Multicultural Problem Gambling Prevention Initiative, awarding grants to five community organizations focused on BIPOC, AAPI, Veterans, LGBTQIA+, and Latine communities to raise awareness and build culturally responsive prevention.

As we look toward 2025, our vision is clear: harness data, innovation, and collaboration to stand between every at-risk individual and the harms of gambling. With your partnership, we will expand our reach, deepen our impact, and continue turning those eye-opening numbers into meaningful change. Thank you for standing with us—because together, we can protect our families, our campuses, and our communities.


Programs & Services

Problem Gambling Helpline: Provides free support, resources and referrals to counseling, 24 hours a day, 7 days a week, to individuals or those impacted by gambling-related harm (available via phone & chat).

Training: in 2023 CCPG offered a total of 59 training courses where 1709 people took the opportunity to increase their knowledge and awareness of problem gambling, as well as ways to integrate these concepts into their work.

Outreach: CCPG staff hosted resource tables at events across Connecticut such as sporting events, resource fairs, veterans' fairs, college campuses, and recovery events.

The College Campus Gambling Prevention Initiative was launched in response to the rising prevalence of gambling among Connecticut's undergraduate population. According to the Gambling Prevalence in Connecticut's Undergraduate study, 73% of students reported gambling in the past year, with frequent engagement in fantasy sports, sports betting, and internet gambling. To address gambling-related harms, CCPG partnered with colleges and universities to educate students, raise awareness, and host resource tables and screening events. Efforts included staff and student training on warning signs and resources, with targeted support for high-risk groups such as Athletes and Residential Life. In the 2023-2024 grant period, over 7,700 individuals were reached, and surveys of more than 200 student athletes further informed these efforts. The program's success has laid the groundwork for expanding these impactful programs to more colleges in the future.



The Fox61 Student News Program provided training and scholarships to students submitting news stories in the category of "Not A Game" discussing Gambling as a co-occurring disorder and potential risks to youth.

CCPG was proud to partner with the Capitol Region Education Council (CREC), and DMHAS Problem Gambling Services (PGS) on the Gambling Awareness Youth Media Project which provided training to middle and high school students including types of gambling, warning signs, risk factors and resources. Students utilize the information learned to create campaigns to educate their peers and communities.



Programs & Services Cont.

The Multicultural Problem Gambling Prevention Program, developed by the Connecticut Council on Problem Gambling in partnership with the Department of Mental Health and Addiction Services, aims to reduce gambling-related harm in under-resourced and historically marginalized communities. In the 2024–2025 grant cycle, five organizations were selected to implement culturally tailored prevention efforts across Connecticut: New England Asian American Cultural Center, The Health Collective, The Windham Region Chamber of Commerce, The Afro Caribbean Cultural Center, and Veterans Strong Community Center. These partners successfully engaged their communities through innovative, culturally relevant outreach—including translated materials, community wellness events, media appearances, and trusted peer-led education—advancing the program’s mission to build protective factors and foster inclusive, prevention-based support across diverse populations.



The Clinical Training Series, a partnership between CCPG, DMHAS, and the CT Clearinghouse, was designed to educate Connecticut residents and clinicians about problem gambling. It included eleven virtual training sessions covering topics such as gambling as a co-occurring disorder, screening and assessment, gender differences, cultural humility, counseling interventions, ethics, harm reduction, convergence of gambling and gaming, recovery supports, and financial management.

Starting in October 2024, Brian Hatch the Community Engagement Manager for CCPG presented at three correctional facilities in Connecticut (Osborn, Cybulski, Robinson). The presentation consisted of Brian’s lived experience with gambling harm intertwined with resources available to those suffering as well as anecdotes from the ten years of Brian’s podcast about gambling harm, all delivered with a light comedic tone. From the reaction of the initial presentation at Cybulski, Brian was asked to run a weekly recovery gambling group consisting of 10-20 gentlemen.

Advocacy



In the 2024 legislative session, the Connecticut Council on Problem Gambling (CCPG) worked diligently to advocate for the interests of individuals and families impacted by problem gambling. CCPG engaged with legislators across multiple committees—including Children, Public Health, Banking, Insurance, Higher Education, Appropriations, and General Law—to address critical issues affecting the gambling harm community. Through meetings and testimonies, CCPG presented legislative priorities focused on creating a safer, more supportive environment for those affected by gambling disorders.

H.B. No. 5284 (RAISED) AN ACT REVISING VARIOUS GAMING STATUTES.

Sen. Gaston, Rep. Boyd, and Members of the Committee: Thank you for the opportunity to testify on this bill concerning various gaming statutes, specifically gambling advertisements. My name is Diana Goode, Executive Director of the Connecticut Council on Problem Gambling (CCPG). Our organization fully supports the intent of this bill to provide protections to marketing gambling products to those under the age to legally partake.

Connecticut has approximately 3,565,000 citizens. That means that over 100,000 citizens and over 275,000 family members are negatively impacted by gambling every day. Using current population

Some of CCPG's key legislative priorities included pausing debt obligations for individuals in treatment, implementing mandatory age verification for lottery purchases, and allowing those aged 16 and older to seek treatment for gambling-related harms without parental consent. Additionally, CCPG aimed to reduce predatory advertising practices within the gambling industry. A notable outcome from this session was the passage of Public Act 24-142, Connecticut's new law imposes stricter rules on gambling advertising, banning agreements where marketers are paid based on how many users wager or sign up, and requiring ads to clearly state age restrictions. It also prohibits targeted ads to self-excluded individuals and any content likely to appeal to or reach underage audiences, while mandating truthful, non-misleading messaging. This act, passed by both the House and Senate and signed by the Governor.







Throughout 2024, the "Responsible Play the CT Way" initiative and its logo have been integral to promoting responsible gambling practices across Connecticut. This collaborative effort, involving the Connecticut Council on Problem Gambling (CCPG), the Connecticut Lottery Corporation, Mohegan Sun, Foxwoods, Sportech, and the Connecticut Department of Mental Health and Addiction Services (DMHAS), has been prominently featured in campaigns designed to educate the public about safer gambling behaviors.

The logo was also showcased in digital marketing efforts, sports betting promotions, and community-focused campaigns, highlighting the state's commitment to protecting players and preventing gambling-related harm. This widespread usage reflects Connecticut's proactive approach to fostering a culture of informed and mindful gambling.

The Connecticut Council on Problem Gambling (CCPG) proudly partnered with the PEZ Corporation to create a custom Responsible Play PEZ dispenser — the first collaboration of its kind by a nonprofit organization. Since receiving delivery, CCPG and our partners have distributed thousands of these dispensers-

throughout the community as part of our outreach initiatives. This unique and engaging tool helps raise awareness about the importance of responsible gambling practices and educates the public on the risks associated with gambling-related harm.



CCPG In The News

Throughout 2024, reporting on Connecticut’s legal gambling surge revealed troubling trends and highlighted CCPG’s leadership in responding to them. In a CT Insider feature titled “a casino in your pocket,” journalists traced how online casino and sports-wagering growth has coincided with spikes in bankruptcies, domestic violence, and even suicide—underscoring that problem gamblers, while a small share of participants, account for a disproportionately large slice of losses . Those findings drove home the need for targeted prevention, and our 24/7 helpline saw a 132% increase in contacts over 2021 levels as college-aged men, veterans, and other at-risk groups reached out for help.

Major outlets also spotlighted CCPG’s proactive campaigns during high-stakes sporting seasons. In coverage around March Madness, reporters emphasized our statewide push—spanning Spanish-language radio, digital ads, and on-campus events—to set time-and-money limits, promote licensed platforms, and normalize self-exclusion tools. Executive Director Diana Goode joined legislators in urging bettors: “If gambling stops being fun, reach out—our helpline is here day or night for anyone feeling trapped or overwhelmed.”

In a standout piece for Gaming Today, US Legislators Introduce GRIT Act to Address Gambling Addiction, by Tebearau Egbe on 1/16/2024, Diana Goode’s words resonated nationwide:

“Gambling-related harm doesn’t recognize borders between cities and states. That is why this federal initiative to provide much-needed funding for prevention, treatment, and research is so vital. In Connecticut, we are fortunate to have robust programs for those impacted by problem gambling and their families. This legislation will allow other states to create similar resources for their citizens.”

Her message became a rallying cry for policymakers and advocates alike, cementing CCPG’s role as both a state leader and a national voice in the fight against gambling-related harm.

Regional Conference



Last month, CCPG joined forces with five fellow Northeast states—Maine, New Hampshire, New York, Rhode Island, and Vermont—to host our first regional conference under the Northeast Consortium on Problem Gambling banner. On Tuesday, May 14th, at the AC Hotel by Marriott in Worcester, MA, over 150 prevention and treatment professionals gathered for “Using Research to Rewrite the Playbook: Examining the Social Impacts of Sports Betting and the Changing Gambling Landscape.” Sponsored by the Massachusetts Gaming Commission, the day unfolded through dynamic sessions covering the evolution of sports wagering, the latest problem-gambling resources, youth and family impacts, cutting-edge responsible-gaming tools, and innovative treatment approaches.

Connecticut’s delegation turned out in force. Jeremy Wampler, DMHAS Problem Gambling Services, delivered a compelling overview of state data on sports-betting trends and emerging risk factors. Stephen Matos from the MCCA shared frontline insights into co-occurring substance-use challenges, and CCPG’s own Kaitlin Brown illustrated how targeted prevention campaigns have shifted campus cultures. Their presentations sparked lively Q&A sessions and laid the groundwork for cross-state collaboration on best practices.





Summary of Revenue & Expenses


For year ending December 31, 2024
